1. Purpose

Broker shall arrange for the transportation of freight on behalf of Shipper through authorized motor carriers.

2. Broker Responsibilities

Broker shall arrange transportation with licensed motor carriers; monitor shipment progress; provide shipment updates when available; and maintain compliance with applicable federal regulations.

3. Shipper Responsibilities

Shipper shall provide accurate shipment information; properly package freight; declare the correct weight and commodity; comply with all shipping regulations; pay all freight charges as agreed; and notify Broker of any special handling requirements.

4. Compensation & Payment Terms

Payment shall be made according to Rate Confirmations issued by Broker. Payment terms are Net 30 days unless otherwise agreed in writing. Late payments are subject to a 1.5% monthly finance charge, or the maximum allowed by law. Broker reserves the right to require prepaid freight charges from Shippers with limited or unsatisfactory credit history. Shipper must notify Broker of any disputed charges within 15 days of invoice receipt; failure to do so constitutes acceptance of the charges.

5. Additional Charges

Shipper agrees to pay all applicable accessorial charges, including but not limited to detention, layover, lumper fees, redelivery, reconsignment, Truck Ordered Not Used (TONU), fuel surcharges, storage charges, and any additional services requested by Shipper.

6. Rate Confirmations

Each shipment arranged by Broker shall be governed by a separate Rate Confirmation, which shall be incorporated into and made part of this Agreement.

PAYMENT TERM APPROVAL

Requested payment terms submitted online are subject to credit review and written approval by Unique Giant Logistics, LLC.



7. Cargo Liability

Motor Carrier shall be liable for cargo loss or damage as provided under the Carmack Amendment (49 U.S.C. §14706). All cargo claims must be filed in writing within 9 months of delivery.

8. Insurance

All carriers utilized shall maintain a minimum of \$1,000,000 Auto Liability Insurance and a minimum of \$100,000 Cargo Insurance. Broker shall verify insurance coverage prior to dispatch of shipments.

9. Independent Contractor

Broker and Shipper shall act as independent contractors. Nothing in this Agreement shall be construed to create a partnership, joint venture, or agency relationship.

10. Indemnification

Shipper agrees to indemnify and hold Broker harmless from any loss, damage, liability, or expense arising from improper packaging, incorrect shipment information, failure to comply with shipping regulations, or hazardous materials not properly declared.

11. Non-Solicitation

Shipper agrees not to solicit, contract with, or otherwise engage any carrier introduced by Broker for transportation services without Broker's involvement for a period of 6 months following completion of shipment.

12. Termination

Either party may terminate this Agreement by written notice. Termination does not relieve either party of payment obligations, claims, liabilities, or other obligations arising from services performed before the effective date of termination.

AGREEMENT EFFECTIVE DATE

The Agreement is submitted on the date of electronic signature and becomes effective only when Unique Giant Logistics, LLC issues written approval. Official approval communications will be sent from an authorized Unique Giant Logistics email address.
